Here's What's New!

Broadband Coming To All of Northfield Township!

Universal broadband access is now completely funded across all of Washtenaw County, a significant achievement and the culmination of efforts that began nearly a decade ago. The county reached a major milestone when elected county leaders voted last year to dedicate \$14.6 million, much of its federal COVID relief dollars, toward extending broadband coverage to more than 3,000 homes that have been left underserved by other federal and state grant programs.

Thank you to the Washtenaw County Broadband Task Force (**www.washtenaw.org/2867/Broadband-Task-Force)** for all of their hard-work and dedication in securing these services for our residents.

The vast majority of the new service, which comes through a

handful of different providers, will be fiber-based internet. A map of expected service dates can be found on the Washtenaw County Broadband Task Force's webpage listed above. New Police Chief And Fire Chief



On September 13, 2022, the board swore-in our new Police Chief, Marty Smith, and our new Fire Chief, Chris Bishop. Development News

- The construction of Chestnut Hills at the corner of Whitmore Lake Rd. and North Territorial is well underway. Once completed, the subdivision will provide 264 housing units - 56 single-family detached homes and 208 attached townhomes.
- ◊ A Request for Proposals (RFP) is being created for 11 acres of property to the rear of the Community Park property (next to the Whitmore Lake Post Office). The RFP would be asking for proposals for mixed use development in our downtown.
- Over the past several years, 75 Barker's fate has been up in the air. The Board discussed many options ranging from renovating the building to demolishing it altogether. The building was put up for sale multiple times, with the sales falling through in the end. One last push to sell occurred last spring. In April 2022, the Board approved the sale of 75 Barker to Soamer Jamil (owner of Lakeside Party Store and Driftwood Marina). The Development Agreement was approved at the Oct. 25 board meeting. Mr. Jamil is purchasing the building and a portion of the parking lot for \$100,000, leaving the remaining spaces for public use. Per the agreement, Mr. Jamil was given 2.5 years to complete construction. Congratulations to Mr. Jamil, and we look forward to another new business in our downtown!
- It has been a busy time in our planning & zoning office. The Twp. Mgr. has been getting quite a few phone calls and requests for meetings with property owners and developers for potential projects throughout the township. It will be exciting to see as these projects begin to develop.



Members and Alternates Needed: Planning Commission, Board of Review, Parks & Recreation Board, DDA, LPC

Northfield Township currently has vacancies on the following Boards and Commissions:

Planning Commission: The Planning Commission advises Twp. officials on matters of planning and development of the community, approves site plans, and makes recommendations for land-use and the environment. The Planning Commission meets on the 1st and 3rd Wednesday of each month and members serve 3-year terms.

Board of Review: The Board of Review reviews the annual assessment roll for complete, accurate, uniform, and valid data, and hears resident appeals. The Board of Review meets in March, July, and Dec. each year and members serve 2-year terms.

Parks & Recreation Board: Members of the Parks & Recreation Board are members of the community interested in advancing recreational opportunities within our township. Parks & Rec. members serve 3-year terms and meet on the 3rd Thursday of the month.

Downtown Development Authority (DDA): The DDA is looking for **business owners** in downtown Whitmore Lake or the US-23 and North Territorial area to join the DDA. The DDA undertakes public improvements and activities that strengthen the business district and attract new private investments. The DDA meets on the 4th Wednesday of each month and members serve 4-year terms.

Land Preservation Committee (LPC): Land Preservation Committee is a committee of residents put together by the Board of Trustees to look at ways to preserve agricultural and natural lands within the township. The LPC meets on the 1st Monday of the month.

Northfield Community Park Trailway Grants

The Township has been working diligently over the past year on the development of the Northfield Community Park (next to the Whitmore Lake Post Office). While it may not appear that much has been done toward the park's development, a lot has been happening behind the scenes to set the stage for construction to begin. The focus for Phase I of the community park has been toward establishing parking areas and pathways.

In March of 2022, the Township was awarded a MDNR Trust Fund grant in the amount of \$300,000 to create a park entrance with a village green feel, along with paved parking and connected pathways (pictured to the right). Construction is slated to begin this spring!

In more recent months, the Township Manager has been meeting with the Director of Washtenaw Co. Parks & Recreation to discuss partnering on

other projects for the Community Park. One idea was to connect the new park to the 8 Mile Road Park & Ride by developing a trail along the railroad track easement. It was determined, however, that this would not be feasible due to the narrow easement in that location. So, we looked at other possible trail connections and the County encouraged us to apply for the "Connecting Communities" grant program. Our grant application was submitted in August 2022. If approved, the grant funding of \$225,000 would allow us to determine the feasibility and construction of a non-motorized trail connection between the Community Park trailways and the Play Path along Barker Rd.

A nine-hole disc golf course was installed in the back area of the park and community events such as the Whitmore Lake Farmer's Market and the DDA's annual Trunk-or-Treat continue to be held at the Northfield Community Park. The Township is continuing to look and apply for other grants and funding opportunities with the focus being on the next stages of construction including the addition of some public amenities such as permanent restrooms and /or a pavilion or amphitheater for public use.



Brian has been with the Wastewater Treatment Plant for the past 12 years and has been working with Dan over the past few months to learn his new role.

Equalization Basin Construction Complete



In 2020, after almost 40 years of discussion and debate, the Northfield Township Board of Trustees approved the construction of an equalization basin (retention basin) at the Northfield Township Wastewater Treatment Plant (WWTP). Construction of the basin began in the spring of 2021 and has now been completed! As part of the construction agreement, the WWTP will be planting 66 new trees around the basin area to replace trees that had to be removed for construction of the basin and to provide screening for the adjacent neighborhood.

Completion of the basin provides the plant with extra storage capacity for holding an additional 1.5 million gallons of material from our sewer systems in times of high-flow. This will allow our WWTP staff the time needed to properly treat all incoming sewage before being released.

Keep Our Waterways Clean - A Word Search!

Have you ever wondered what happens to <u>stormwater</u> after a storm? Stormwater, the <u>runoff</u> water after it rains or snows, <u>flows</u> from parking lots and streets into storm drains or directly into nearby water sources. Storm drains channel the stormwater directly to the nearest <u>waterway</u>, usually with little or no treatment. So whatever flows down a storm <u>drain</u> or is collected by natural runoff comes out in nearby waterways, such as our <u>wetlands</u>, <u>streams</u>, <u>ponds</u>, and <u>lakes</u>.

Please help keep our local waters clean:

~ Never <u>dump</u> anything down storm drains - this includes <u>litter</u>, sand, leaves, lawn clippings, pet waste, motor oil, or paint.

~ Clear sand, leaves, litter, debris, and snow away from storm drains.

~ Clean up after your pet! <u>Pet-waste</u> contains germs that can be <u>harmful</u> to human health and to our waterways.

~ Maintain your vehicle regularly to <u>prevent</u> fluid leaks, and wash your vehicle where the soapy water can soak into the <u>ground</u> instead of flowing into a storm drain or waterway. (Did you know that just one quart of <u>motor-oil</u> can produce a one-acre oil slick or <u>contaminate</u> 250,000 gallons of drinking water?)

Treasurer's Office Tidbits

Winter Tax Information

Winter Taxes are due by **Tuesday, February 14, 2023,** to avoid interest and penalty. The Northfield Township office will be open until **5:00 pm on Tuesday, December 27, 2022, for tax payments**. Please note that postmarks are not accepted as payment date. Failure to receive your tax bill does not exempt you from paying or being assessed late charges.

Past due taxes are payable at Northfield Township through February 28, 2023. Any unpaid taxes will be transferred to the Washtenaw County Treasurer for collection thereafter. The Township cannot legally accept tax payments after February 28, 2023.



Taxes are payable by cash, check, or credit/debit card. For payments by check, **please verify all information is correct on your check before mailing. Please include your phone number on your check. Post dated checks are not accepted and will be returned**. For your convenience, there are two 24-hour payment drop boxes at the Township offices. One is located along the sidewalk leading to the front doors (pictured here), and the other is in the vestibule just inside the first set of doors. We highly encourage you to utilize the 24-hour drop boxes as there have been delays in the mail; postmarks are not accepted as payment date!

You may pay your taxes with credit/debit card or e-check on our website at <u>www.twp-northfield.org</u> or by calling 1 (833) 733-6290. Please note, the credit card service provider charges a 3% fee of the amount paid by credit or debit card. The fee for an electronic check is \$3.00 for payments under \$10,000 and \$10.00 for payments over \$10,000.

Personal Property Tax for Businesses

Personal property used by businesses has been subject to taxation in Michigan. Business Personal Property generally consists of furniture and fixtures, machinery and equipment, computers, etc. All tangible personal property in your possession as of **December 31st of the preceding year**, including fully appreciated and expensed assets, must be reported. The Personal Property Statement form is mailed each year in December. If you do not receive a form, you can print a copy from the state treasury website at: http://www.michigan.gov/documents/taxes/632_2011_337716.6.pdf

Qualifying for Personal Property Tax Exemption

Effective in 2014, an exemption was created for the personal property owned by businesses if the true cash value of the personal property owned, leased, or possessed by a business or a related party is **less than \$80,000** within the assessment jurisdiction. This exemption has become known informally as the 'small taxpayers' exemption and the exemption is only for commercial and industrial personal property. **(Please note, in 2023 this limit will increase to \$180,000)**.

To claim this exemption, the business must file Form 5076 - Small Business Property Tax Exemption Claim Under MCL 211.90. This form must be filed (postmark is acceptable) with the Assessing Department by February 20th each year. Effective the 2019 tax year, once the small taxpayer's exemption has been granted, it will remain in place unless denied by the assessor or unless the business exceeds the \$80,000 limit (in which case the business must file a Personal Property Statement with the assessor).

Property owners who timely file Form 5076 are not required to file a **Personal Property Statement**. Taxpayers are required to maintain books and records for four years after filing a form claiming the exemption; penalties apply for fraudulent exemption claims.

Sold, Closed, Or Moved Your Business?

December 31st is the Tax Day in the State of Michigan. Unlike real property where taxes are prorated at the time of sale, a **personal property tax is due for the entire year**. For example, if your business moves out of the Township on any day during the calendar year following Tax Day (December 31st), you, as a business owner, are still liable for the personal property tax for the remainder of the calendar year. Personal property taxes would be due to Northfield Township if your business re-locates to the following year. Your business cannot be taxed a personal property tax by two jurisdictions in the same year.

Election Information

Board Seats:

Treasurer Jacqueline Otto, and Trustee Rachel Smith were appointed by the board in 2021 to fill vacancies after Treasurer Zelenock's resignation. Because these were

mid-term appointments, it was required to put these two board positions on the 2022 ballot for a vote of the citizens. On November 8th, both Treasurer Otto and Trustee Smith were elected into their positions and will serve until their terms end in Nov. 2024.

Farmland Preservation Millage:

The Farmland and Adjoining Natural Area Preservation Millage passed with 56.48% of the vote. This millage will add 0.6 mills (\$0.60 per \$1,000 of taxable value) for 5 years (2023 through 2027), and the funds collected will be used toward the voluntary purchase of development rights for existing farms in Northfield Township. Whitmore Lake Public Schools Millage:

Whitmore Lake Public Schools' proposal to increase their operating millage to 21 mills did not pass, but by a very narrow margin. The school will be considering bringing this item back to the electors in 2023.
